They want the ability to continue hunting mountain lions and not have them banned as in California. The trappers in attendance do not want to trap/snare lions nor do they want the size trap required to do so, be out there. Nobody was in favor of taking predator money for this project. We have a Wildlife Damage Committee, if there is a problem in a specific area, the mountain lion can be addressed there.
