We, the NBU Board of Directors, appreciate the opportunity to again Auction any or all of the tags mentioned above.

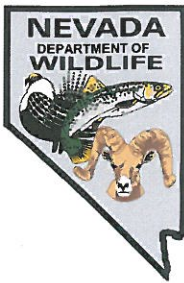
