### APPLICATION INFORMATION ONLY

Any remaining swan hunt permits will be available on a first come, first served basis online or through the mail up to 7 weekdays before the close of the season or over the counter during business hours (M-F 8:00 am - 5:00 pm) at the Wildlife Administrative Services Office, 185 North Maine Street, Fallon, Nevada beginning on Monday, October 5, 2009. Applications are available at all Department of Wildlife offices and select license agents. Applicants can submit one application during the initial draw period. Persons may apply for a second swan hunt permit beginning on Monday, October 5, 2009 during the first-come first-served draw period. Applicants that did not apply for the initial drawing may submit two applications during the first-come first-served draw period.

### LICENSE REQUIREMENTS

In addition to the Swan permit, hunters must possess a valid Nevada hunting license and both a current Federal Migratory Game Bird Hunting stamp and a current Nevada Duck Stamp, when required, to hunt swan in Nevada.
