



# 2011 Remaining Tag Drawing Information RESIDENT APPLICATION PROCEDURE REGULATIONS

It is the applicant's responsibility to contact the Wildlife Administrative Services Office if notice is not received (tag, refund, or letter) prior to the start of the hunt at the following address or phone numbers. **Wildlife Administrative Services Office, P.O. Box 1345, Fallon, Nevada 89407-1345. 1-800-576-1020 or local calls (775) 423-7577.**

## RESIDENT REMAINING TAG DRAWING INFORMATION

A second drawing will be held for all remaining quotas. Applicants who are eligible may apply for remaining tags in the second drawing. Remaining tags in each type of hunt (except for junior hunt, antlerless deer, depredation deer and cow elk) will be available to both the resident and nonresident applicants who are eligible.

Except for 1101 depredation hunts, emergency deer hunts, and landowner damage compensation tags, a person may not obtain more than one deer tag for the 2011 season.

Applications must be submitted to the Wildlife Administrative Services Office, P.O. Box 1345, Fallon, Nevada 89407-1345, through a postal service or online at [www.huntnevada.com](http://www.huntnevada.com). The applicant is responsible for mailing applications to the correct address. Applications received at the Department of Wildlife offices will be date stamped and returned to the applicant. **DO NOT MAIL APPLICATIONS TO THE DEPARTMENT OF WILDLIFE.**

After the first drawing results have been mailed, the Wildlife Administrative Services Office will only accept those applications received until **5:00 p.m., June 28, 2011**. All applications received after **5:00 p.m., June 28, 2011** will be processed as late applications and are not eligible for the draw.

Results of the second drawing will be provided by **July 15, 2011**. Information will not be given over the phone until **July 15, 2011**. The draw reports will be available at the Wildlife Administrative Services Office and the Department offices in Reno, Elko, Ely, Winnemucca, Fallon, Henderson, Las Vegas, and online at [www.huntnevada.com](http://www.huntnevada.com) after the tags and refunds have been mailed on or before **July 15, 2011**.

Remaining tags will be sold until seven (7) weekdays prior to the close of the season for the tag.

## HUNTING LICENSE REFUND

Applicants unsuccessful in drawing a big game tag, who purchased a hunting license for the sole purpose of applying for big game tags, will receive a full refund if the license is returned to the Nevada Department of Wildlife Reno Headquarters on or prior to the last weekday of August, 2011. **UNSUCCESSFUL APPLICANTS WHO OBTAIN A LICENSE REFUND WILL NOT GAIN ANY BONUS POINTS OBTAINED THAT YEAR.**

## INSTRUCTIONS FOR COMPLETING APPLICATIONS

**Read the application procedure regulations before proceeding.**

**All applications must be received in the Wildlife Administrative Services Office by 5 p.m. on the deadline date. Mail early. Applications must be mailed through an authorized postal service. Hand delivered applications will not be accepted. Apply online at [huntnevada.com](http://huntnevada.com) by 5:00 p.m. on the deadline date.**

1. Fill in your sportsman's ID or Social Security number (SSN) and daytime phone number. (SSN required if purchasing a license in step 7).
2. Fill in your date of birth.
3. Print your name, address, city, county, state, zip code and driver's license number.
4. Complete residency information, years and months.
5. Indicate the number of hunters in your party in the box provided (deer hunts only). **Staple applications together.**
6. Refer to the Season/Quota table in this application brochure for the type of hunt category for which you are applying and select the correct THREE-DIGIT HUNTER CHOICE NUMBER corresponding to where you wish to hunt. Write the hunter choice on the same line as the type of hunt.
7. Mountain Lion Tag – this is an optional purchase and not required. Mark the appropriate box and submit fee if you choose to purchase a mountain lion tag.
8. Fill in your hunting license CLASS NUMBER, hunting LICENSE NUMBER and YEAR.
9. If you are unsuccessful and wish to donate all or part of your refund to Operation Game Thief, fill in an amount.
10. **Sign and date your application.**
11. Submit the total fees. **MAKE CHECKS PAYABLE TO NEVADA DEPARTMENT OF WILDLIFE (NDOW).** **(No out-of-state personal checks or company checks accepted.)** Please submit separate checks when applying for big game and deer hunts; one check for big game applications and one check for deer applications. (payor address on the personal check must be in-state, not the bank's address.)
