

## 2009 BIG GAME QUOTAS CR 09-07

The Board of Wildlife Commissioners under the authority of sections 501.181, 502.140, 502.250, 503.120 and 503.140 of the Nevada Revised Statutes, does hereby adopt the following regulation for the big game resource.

Note: The limit is one and the hunting hours are one-half hour before sunrise to sunset for all big game hunts, unless otherwise specified.

It is the hunter's responsibility to meet and/or comply with all NTTR eligibility requirements. In some units there may be adjustments to season dates to accommodate Department of Defense operations. The Nevada Board of Wildlife Commissioners hereby delegates authority to the Nevada Department of Wildlife to adjust season dates to accommodate Department of Defense operations so long as there is no change to the overall length of the season.
