Items of question include: 1- Legalities surrounding job performance and possible firing of personnel in relation to maintaining “high” wildlife numbers. 2- Increasing AUM allocations which are controlled by the Federal Land Management Agencies. 3- The document formatting came into discussion. It was discussed that some adjustment could be done which would clarify items, issues, and recommendations and then a more formal and precise message could be the result. 4.
