4. **Correspondence, Reports, Public Comment**-NDOW report-Ed Partee discussed proposed changes to Sage Grouse and Turkey hunts. Cody Byrne reported for fish plantings of streams and reservoirs in Humboldt County had been done.
5. **Action Item 17 –Commission Regulation 07-07 Amendment #6-**
 - Larry Allen motioned to accept the Dept. recommendations for upland game seasons and bag limits. Michael Jurad seconded the motion. All in favor. No apposed. Passed (3-0)
 - Michael Jurad motioned to accept the Dept. recommendations for furbearer animals with the inclusion of grey fox to concur with the bobcat and pelt sealing dates. Larry Allen seconded the motion. All in favor. No apposed. Passed (3-0)
6. **Action Item 16A –Commission General Regulation 383, LCB File No. R005-10-**
 - Steve Hemp motioned to support LCB File No. R005-10-Wildlife Highway Crossing as is. Larry Allen seconded the motion. All in favor. No Apposed. Passed (3-0)

7. **Action Item 16B-Commission General Regulation 389, LCB File No. R083-10-**
 - Steve Hemp motioned to support LCB File No. R083-10 providing it doesn't encompass blinds. All in favor. No Apposed. Passed (3-0)

8. **Action Item 21-Petition NOGA-NAC 502.4237-**
 - Michael Jurad motioned to support the petition of NOGA to return to the original wording of NAC502.4237 to allow unsuccessful applicants in the non resident guided hunt to reapply in the main draw for deer. No second. Motion died.

 - Steve Hemp motioned to not support(deny) the petition of NOGA to return to the original wording of NAC 502.4237 to allow unsuccessful applicants in the non resident guided hunt to reapply in the main draw for deer. Larry Allen seconded the motion. Passed (3-1) with Michael Jurad apposed.

9. **Action Item 18-Duck Stamp Request-**
 - Steve Hemp motioned to support Dept. request for funding of 23 projects from Duck Stamp funds totaling \$141,036. Larry Allen seconded the motion. All in favor. No Apposed. Passed (3-0)

10. **Action Item 19-Upland Game Stamp Request-**
 - Larry Allen motioned to support Dept. request for funding of 10 projects from Upland Game Stamp funds totaling \$172,110 and \$160,000 for a total of \$332,110. Michael Jurad seconded the motion. All in favor. No Apposed. Passed (3-0)

11. **Action Item 22-Wildlife Heritage Projects-**
 - Steve Hemp motioned to support heritage project proposal number **09-08** which requested an extension of funding into fiscal year 2011. Larry Allen seconded the motion. All in favor. No Apposed. Passed (3-0)
