THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** NRS 501.356 is hereby amended to read as follows:
2 501.356 1. Money received by the Department from:
3 (a) The sale of licenses;
4 (b) Fees pursuant to the provisions of NRS 488.075 and 488.1795;
5 (c) Remittances from the State Treasurer pursuant to the provisions of
6 NRS 365.535;
7 (d) Appropriations made by the Legislature; and
8 (e) All other sources, except money derived from the forfeiture of any
9 property described in NRS 501.3857 or money deposited in the Wildlife
10 Heritage Trust Account pursuant to NRS 501.3575 or in the Trout
11 Management Account pursuant to NRS 502.327,
12 ↪ must be deposited with the State Treasurer for credit to the Wildlife
13 Account in the State General Fund.
14 2. The interest and income earned on the money in the Wildlife
15 Account, after deducting any applicable charges, must be credited to the
16 Account.

1 3. Except as otherwise provided in subsection 4, the Department may
2 use money in the Wildlife Account only to carry out the provisions of this
3 title and chapter 488 of NRS and as provided in NRS 365.535, and the
4 money must not be diverted to any other use.

5 4. Except as otherwise provided in NRS 502.250 and 504.155, all fees
6 for the sale or issuance of stamps, tags, permits and licenses that are
7 required to be deposited in the Wildlife Account pursuant to the provisions
8 of this title *and any matching money received by the Department from*
9 *any source* must be accounted for separately and ~~may~~ must be used
10 ~~only~~ :

11 (a) Only for the management of wildlife ~~and~~ ~~only~~
12 ~~upon approval by~~

13 (b) If the fee is for the sale or issuance of a license, permit or tag
14 other than a tag specified in subsection 5 or 6 of NRS 502.250, under the
15 guidance of the Commission ~~and~~ pursuant to subsection 2 of NRS
16 501.181.

17 **Sec. 2.** This act becomes effective on July 1, 2009.
