(a) An applicant for a guide's license must provide proof of current certification in a Red Cross Standard First Aid course or an equivalent approved by the Department with his original application for a license and must maintain certification or license will be suspended.

(b) Boating Safety Requirements: An applicant for a guide's license must provide proof of his United States Coast Guard License, if required for the body of water where the guiding will take place. If a boat will be used to provide a service to a client and a United States Coast Guard License is not required, the applicant must provide proof that he has successfully obtained a minimum score of 80 percent on the boating safety examination in the Navigating Nevada booklet, which may be obtained free of charge from the Nevada Department of Wildlife, Law Enforcement Division, 6980 Sierra Center Parkway, Suite 120, Reno, NV 89511.

(c) **New applicants must pass an examination related to hunting or fishing with a minimum score of 80%.**

(d) **New applicants must provide proof of completion in a course on the responsibilities of hunters (hunter safety).**
