### Minutes

The Eureka County Wildlife Advisory Board (CAB) met in the Eureka County Administrative Facility (Annex) on June 18, 2020 at 4:30 p.m.

**Members Present:** Chairman Jim Evans and Vice-Chair Trent Gordon.

#### **Call to order**

Chairman Evans called the meeting to order at 4:30 p.m. a quorum was determined to be present.

#### **Wildlife Habitat Enhancement Projects**

Clint Garrett stated he was in the process of putting polygons together for Pinyon-Juniper (PJ) removal. The board, along with Mr. Garrett, had a discussion on what the process is for Mr. Garrett on where polygons will be placed.

Mr. Evans noted that Cold Springs reservoir is at the minimal water level at this time. The water level should not increase or decrease moving forward. Renovations should start towards the end of summer, early fall.

**12: Mule Deer Enhancement Program**

The board and Mr. Garrett discussed what the Mule Deer Enhancement Program would entail. The program would create Mule Deer Teams based on hunt units. The teams will rank limiting factors for each hunt unit. The units for Eureka would be 13 and 14. The teams would then develop/prioritize project proposals to address limiting factors in their areas.

Mr. Evans noted he would like the CAB to keep kept in the loop if the program does move forward. The board would like to be actively involved with the program.
