DRAFT MINUTES

- I. Meeting was called to order at 5:33 by Chairman Scott Torgerson
- II. Members present were: Ted McElvain, Shawn Mariluch, Worth Nelson, Colt Spealman & Scott Torgerson
- III. Shawn Mariluch motioned to approve the agenda. The motion was seconded and carried.
- IV. Shawn Mariluch motioned to approve the minutes of the March 12, 2019 meeting. The motion was seconded and carried.
- V. Correspondence—Scott Torgerson reported that the Washoe CAB President is his dentist and told Scott that the Washoe CAB would like to leave the ewe sheep hunt in Area 6 at 1.

- VII. New Business
 1. Update from NDOW Biologist Sarah Hale. She moved here from Montana. Tom Donham was also at the meeting. They stated that they would give us the updates as we go over the quotas.
 2. Discussion and possible recommendation about the Use of ‘Smart’ Technology to hunt that connects Phone/Scope/Range Finder
Worth Nelson provided an article and read a portion of it. The CAB agreed that Worth Nelson should write up something and bring it to the next CAB meeting for approval and then take it to the state meeting in Hawthorne.
 3. Action on Big Game Quotas
Item #1—Shawn Mariluch made a motion to approve the Resident and Nonresident Black Bear—either sex—any legal weapon Hunt 6151 & 6251. . Motion was seconded and it carried.
Item #2—Shawn Mariluch made a motion to change the quota to 265 antelope longer than ears. The motion was seconded but it did not pass. Shawn Mariluch made a motion to agree with the quota. The motion was seconded and carried.
Item #3—Shawn Mariluch made a motion to increase the number of antelope horns shorter than ears, all weapon classes hunt quotas recommended to 240 (increase of 50) on the west side of US 305 Units 151, 153, & 156. The motion was seconded and carried. Shawn Mariluch made a motion to agree with the quota recommendations for Units 141, 143, 152, 154, & 155. Motion was seconded & carried.

Item #4—Shawn Mariluch made a motion to agree with the Nelson Bighorn Sheep any ram, any legal weapon hunts quota suggestion. The motion was seconded & carried.

Item #5—Scott Torgerson made a motion to change the recommended quota amount on the Nelson Bighorn Sheep, any ewe, any legal weapon hunts for the resident in Unit 213 to 25 and Unit 268 to 30 and the Non-resident Unit 213 to 2 and Unit 268 to 3. The motion was seconded & approved.

Item #6—Scott Torgerson made a motion to approve the recommended quota for California Bighorn Sheep, any ram, any legal weapon hunts. The motion was seconded & carried.

Item #7—Scott Torgerson made a motion to change the recommended quota to 1 for California Bighorn Sheep, any ewe, any legal weapon hunts. The motion was seconded & carried.

Item #8—Shawn Mariluch made a motion to approve the recommended quota for Rocky Mountain Bighorn Sheep. The motion was seconded and carried.

Item #9—Ted McElvain made a motion to approve the recommended quota for Mountain Goat. The motion was seconded & carried.

Item #10—Shawn Mariluch made a motion to approved the recommended quota for Elk, antlered & Antlerless for depredation hunts. The motion was seconded and carried.

Item #11— Shawn Mariluch made a motion to approved the recommended quota for Elk Antlered, all weapon classes hunts. The motion was seconded and carried.

Item #12—Shawn Mariluch made a motion to approve the recommended quota for Elk, spike, any legal weapon hunts. The motion was seconded and carried.

Item #13—Shawn Mariluch made a motion to approve the recommended quota for Elk, antlerless, all weapon classes hunts. The motion was seconded and carried.

Item #14—Scott Torgerson made a motion to approve the Elk, antlerless, management, all weapon classes hunts. The motion was seconded and carried.

Item #15—Shawn Mariluch made a motion to approve the Junior Mule Deer, antlered or Antlerless, All Weapon Classes Hunts. Motion was seconded and it carried.

Item #16—Shawn Mariluch made a motion to approve the Mule Deer, antlerless, any legal weapon hunt. Motion was seconded and it carried.

Item #17—Shawn Mariluch made a motion to approve the recommended quota for Mule Deer, antlered, all weapon classes hunts. The motion was seconded and carried.
