Petition - Amendment to Shed Antler Regulation – Jim Cooney, Elko CABMW – Mr. Cooney, on behalf of the Elko CABMW, has submitted a petition to change regulation to amend NAX 503.172, season closure amended read: February 1 thru March 31, with the ability of NDOW to extend season closure based on weather or herd condition for the shed antler collection, to replace January 1 thru April 30.” The Commission may take action to deny or accept the petition and initiate rulemaking.

Charlie Cecchini made a motion to recommend a season closure during Feb 1 through March 31; Chrissy Pope seconded; 3 yeas.

Charlie Cecchini made a motion for to support Elko County petition with Recommendation 1 and 2 and not support Recommendation 3; seconded by Chrissy Pope; 3 yeas.
