Commission General Regulation 19-14, Big Game Quotas for the 2019-2020 Season – Wildlife Staff Specialists Mike Cox, Cody Schroeder, Cody McKee, and Pat Jackson – The Commission will establish regulations for the numbers of tags to be issued for mule deer, pronghorn antelope, elk, bighorn sheep, black bear, and mountain goats for the 2019 - 2020 seasons.

Big Game Quotas:

Mule Deer – Chrissy Pope made a motion to accept NDOW recommendations for all mule deer from page 20-29; Kevin Strozzi seconded; 4 yeas.

Pronghorn Antelope - Kevin Strozzi made a motion to accept the recommendations as proposed; seconded by Steve Bayne; 4 yeas.

Elk – Steve Bayne made a motion to accept all proposed as recommended by NDOW; Chrissy Pope seconded; 4 yeas

Bighorn Sheep – Kevin Strozzi made a motion to accept all except an alternative recommendation for South and North 173 same as last year; John Terras seconded; 4 yeas.

Black Bear – No discussion

Mountain Goats – No discussion
