PLEASE READ THE FOLLOWING INSTRUCTIONS PRIOR TO COMPLETING THE APPLICATION. MISSING INFORMATION MAY CAUSE THE APPLICATION TO BE RETURNED TO YOU FOR CORRECTION.

1. "Resident" means any person who is a citizen of, or is lawfully entitled to remain in, the United States; and during the 6 months next preceding his application was physically present in Nevada, except for temporary trips outside of the state; and did not purchase or apply for any resident license, tag or permit to hunt, fish or trap in another state, country or province.
2. Each application must be accompanied by the proper fee; submit a cashier's check or money order. **OUT-OF-STATE personal or company checks are not accepted. \$25.00 return check fee for checks returned by the bank.**
4. Applicant **must attach** proof of residency for each member of the group that is a resident (may include Nevada driver's license or other proof, containing name and address and dated 6 months prior).
5. Complete all information for each member in your group, or your application will be returned to you for completion.
6. Each Group Permit requires a Primary Adult (18 years of age or older) and at least one child (12-15 years of age).
7. One permit will be issued to each member in the group.
8. Any one (1) person in the group is required to be a Nevada Resident for all members in the group to qualify for Resident Fees.
9. Use additional applications to include all members in your group permit application.
10. **Please allow 10 to 14 days for processing.**
