PLEASE READ THE FOLLOWING INSTRUCTIONS PRIOR TO COMPLETING THE APPLICATION. MISSING INFORMATION MAY CAUSE THE APPLICATION TO BE RETURNED TO YOU FOR CORRECTION.

1. Each Mentor Affidavit requires the applicant to be at least 18 years of age.
2. The applicant must hold a current Nevada annual hunting license.
3. "Resident" means any person who is a citizen of, or is lawfully entitled to remain in, the United States; and during the 6 months next preceding his application was physically present in Nevada, except for temporary trips outside of the state; and did not purchase or apply for any resident license, tag or permit to hunt, fish or trap in another state, country or province.
4. Applicant **must attach** proof of residency (may include Nevada driver's license or other proof, containing name and address and dated 6 months prior.)
5. Prior to entering the field with your Apprentice, the mentor affidavit must be signed and the affidavits initialed by the applicant.
6. Prior to entering the field with your Apprentice, the Licensed Apprentice Hunter name must be printed clearly on the mentor affidavit.
7. A mentor can have more than one apprentice, but can only mentor one apprentice at a time.
8. A mentor must have a mentor affidavit for each apprentice he will mentor.
