## TRANSFER ON DEATH APPLICATION NRS/NAC Chapters 488

Transfer on Death allows motorboat owners to add or remove a beneficiary to their title. The motorboat owner can be an individual or a business. A title fee, the Certificate of Title, and this application must be submitted to the Department of Wildlife to make this change. A new Nevada Certificate of Title will be issued with the beneficiary's name and the Transfer of Death designation.

A beneficiary cannot be added to the title when there is an ownership designated as Tenants in Common. The beneficiary does not have interest or control of the motorboat. If a lienholder or lessor is added to the title at a later time, the beneficiary will be removed from the title.

To transfer the ownership to the beneficiary, the beneficiary must submit the title (if available), title fee, and certified death certificate of the motorboat's legal owner(s). If more than one owner is on the title, the beneficiary cannot become the motorboat owner until all owners are deceased.
