**To:** Nevada Board of Wildlife Commissioners, County Advisory Boards to Manage Wildlife, and Interested Publics

**Title:** Commission Regulation 19-05, 2019-2020 and 2020-2021 Big Game Seasons – For Possible Action

**Description:** The Commission will consider adopting 2019-2020 and 2020-2021 hunting seasons and dates for mule deer, pronghorn antelope, elk, bighorn sheep, and mountain goat, including limits, hunting hours, special hunt eligibility, animal sex, physical characteristics, hunt boundary restrictions, and legal weapon requirements, and emergency depredation hunt structure and statewide quotas.

**Presenter:** Wildlife Staff Specialists Mike Cox, Cody Schroeder, and Cody McKee

Summary:

The Department is presenting the proposed seasons for mule deer, pronghorn antelope, elk, bighorn sheep, and mountain goat for the 2019-2020 and 2020-2021 hunting seasons. Proposed season changes are annotated with a number in the right-hand margin that corresponds with a brief explanation of the rationale for the changes. In general, seasons are suggested to facilitate hunter access to wildlife that move among administrative boundaries or move seasonally, accommodate interstate herds or occupy lands managed by Department of Defense, address nonresident seasons, and alter seasons as needed to address populations in relation to management objectives. The specific rationales are included in a three-page appendix following the proposed seasons.

Recommendation:

The Department recommends that the Commission **VOTE TO ADOPT COMMISSION REGULATION 19-05, 2019-2020 AND 2020-2021 BIG GAME SEASONS AS PRESENTED.**

## CR 19-05

### 2019-2020 and 2020-2021 BIG GAME HUNTING SEASONS

The Board of Wildlife Commissioners under the authority of sections 501.181, 502.140, 503.120 and 503.140 of the Nevada Revised Statutes, does hereby adopt the following regulation for the big game resource.

**Note:** The limit is one animal per tag and the hunting hours are one-half hour before sunrise to one-half hour after sunset for all big game hunts, unless otherwise specified.

## **Rationale for Season Amendments**

1. Added nonresident archery season to provide for 10% quota to nonresidents aligned with resident season.
2. Hunt previously ended on January 31. With elk herds within objective, we can shorten season similar to those from late elk hunts in portions of Elko County, White Pine County, and Lincoln County.
3. A portion of the 061, 071 herd containing older aged bulls move into Idaho before the start of the existing early season hunt. Snow accumulations can also limit hunter access during the existing late season hunt. Propose shifting any legal weapon bull elk hunts earlier to improve harvest metrics and provide better hunter access.
4. Aligning season dates of the interstate hunt shared with Utah.
5. Added nonresident season to provide for 10% quota to nonresidents aligned with resident season.
6. The Department recommends eliminating the mid-season spike hunt and an earlier opening for the late spike hunt in Unit Group 061, 071. Existing season dates for the mid-season overlap the proposed season dates for the early rifle bull hunt. Proposed structure for the late spike hunt will provide a long late season that can support additional spike tags to accommodate those lost from the elimination of the mid-season hunt, if needed, and will allow hunters to plan their activities around winter weather.
7. The Department recommends an earlier opening date for the late cow hunt in Unit Group 061, 071 (November 6) due to the proposed shift of the rifle bull season. Proposed structure will provide a long late season that can support larger quotas if needed, while allowing hunters to plan their activities around winter weather.
8. Recent hunter success in Units 073 and 074 has been low when offered as stand-alone hunts. The population of elk using these three units is managed with a single population objective and the Department no longer requires stand-alone hunts to achieve management goals for this elk herd. The combination of these units is expected to improve hunter experience.
9. Coordination with Utah Division of Wildlife Resources identified an opportunity for an interstate antlerless elk hunt in Unit 091. Nevada and Utah hunters may hunt within open units in both states during the proposed season.
10. This elk population is among the few that is above population objective. The Department recommends adding a long late season to accommodate an anticipated increase in recommended quotas and to reduce hunter congestion.

11. This hunt would focus hunter pressure during late season when many elk move back onto Nevada public lands after the conclusion of the existing late cow hunt (ending on January 5). While the elk herd in Area 11 is within the confines of its management objective, a large portion of the herd residing in Unit 113 escapes hunting pressure by seeking refuge on nearby tribal lands during the existing elk seasons. The Department has received concerns that winter concentrations of elk in this portion of Unit 113 may be degrading native rangeland.
12. Added nonresident season to provide for 10% quota to nonresidents aligned with resident season.
13. Combining hunt dates from 3<sup>rd</sup> and 4<sup>th</sup> hunts from 2018-2019 hunt structure. Low hunter success during existing season structure indicates simplification will not detrimentally effect harvest goals.
14. Change reflects season adjustment for corresponding mule deer hunt. This change adjusts season dates to a historic structure for 3-way seasons splits.
15. Regular antlerless elk hunts can be used to keep this population at or near objective and the antlerless elk management hunts are no longer necessary to achieve harvest goals.
16. The Department recommends adjusting season dates to provide hunters greater access to animals that move seasonally among various habitats or boundaries.
17. Season dates are recommended to accommodate longer seasons for hunters with split seasons.
18. Season dates are adjusted to accommodate access onto lands managed by the Department of Defense.
19. The addition of nonresident seasons allows nonresident quotas to be spread more broadly among units and reduces the number of nonresident hunters within a specific unit.
20. Units 212 and 253 ewe hunts are recommended for removal because the population objective for these units have been met.
21. Herd is recovering and an opportunity to harvest mature rams now exists.
22. Interstate herd managed cooperatively with Utah.
23. Recommend combining Hunt Units 021 and 022 to address recent changes in hunter access in Unit 022 and potential changes in mule deer habitat due to major wildfires in this hunt unit. The Junior mule deer season dates were adjusted accordingly to be consistent with the corresponding 1331 and 1332 season changes.

24. Units 101–109 shortened Muzzleloader season to begin on September 10 and end on September 30; extended Any Legal Weapon season to begin on October 1 and end on November 2; to restore original three season hunting season structure.
25. Recommend combining Hunt Units 021 and 022 to address recent changes in hunter access in Unit 022 and potential changes in mule deer habitat due to major wildfires in this hunt unit. The early and late Any Legal Weapon seasons were adopted from other hunt unites in northern Washoe County with similar mule deer distribution and habitats.
26. Extended season dates Hunt Units 041 and 042 to begin on October 5 ending on November 5 to improve hunt success rates for this Unit group.
27. Units 101–109 extended the Any Legal Weapon early season to begin on October 1 and end on October 16 to restore original three season hunting season structure and increase hunt success for this Unit Group.
28. The Department recommends restructuring the 171–173 seasons to have an Early, Mid, and Late season structure similar to Management Area 22. This should increase hunt success and spread hunters over a longer season to decrease hunter congestion.
29. Recommend combining Hunt Units 021 and 022 to address recent changes in hunter access in Unit 022 and potential changes in mule deer habitat due to major wildfires in this hunt unit. Muzzleloader season recommended to be consistent with other hunts in northern Washoe County.
30. Removed language for emergency hunts being administered in different ways depending on the quota allocation. All emergency hunts will be administered by a randomized computer draw through [www.ndowlicensing.com](http://www.ndowlicensing.com).
31. Removed special eligibility restrictions for emergency hunts to be consistent with CR 19-11.
