**Friday, April 16, 2021 – 9:00 a.m.**

**1. Call to Order, Introduction and Roll Call of Commission and County Advisory Board Members to Manage Wildlife (CABMW) – Chairwoman East**

Chairwoman East called the meeting to order at 9am. Commissioner McNinch led the Commission in the Pledge of Allegiance. Executive Assistant Missy Stanford conducted Commission roll call. Commissioner Hubbs joined late. Chairwoman East asked for the CABMWs to raise their hands, no CABMWs in attendance.

**2. Approval of Agenda – Chairwoman East– For Possible Action**

The Commission will review the agenda and may take action to approve the agenda. The Commission may remove items from the agenda, continue items for consideration or take items out of order.

*Commissioner Hubbs joined the meeting.*

Chairwoman East asked from comments and questions from the Commissioners. Seeing none, she went out for public comment.

No public comment.

**CHAIRWOMAN EAST MOVED TO APPROVE THE AGENDA. SECONDED BY COMMISSIONER MCNINCH. MOTION CARRIES, 9-0.**

**3.\* Legislative Committee Report – Committee Chairwoman East – For Possible Action**

A report will be presented on the committee’s recent meetings. The Commission may review bills of interest and any associated amendments, consider legislative committee recommendations and may take official positions on those bills. The Commission may also choose to develop platforms on bills by supporting or opposing general concepts. (Support materials are as of the Legislative Committee meeting held on March 30, 2021. Management Analyst Kailey Taylor went over the bills that would be discussed at this meeting and the bills that did not pass the first committee passage deadline, which includes: Assembly Bill (AB) 117, revises provisions governing wildlife tags, Senate Bill (SB) 180, revises provisions relating to fire protection, AB433, revises provisions relating to the Sagebrush Ecosystem Program, and AB234, revises provisions relating to charitable lotteries and charitable games. She meant to add two additional bills to the tracking sheet that will be discussed today: AB202 and AB2. The bills discussed at this meeting would be AB286, which makes it unlawful to possess a firearm in a covered premise without the written consent of the owner; SB78, expands the membership of the Member of the Board of Wildlife Commissioners, AB299, makes various changes relating to wildlife, AB211, makes various changes relating to wildlife, SB344, enacts provisions relating to the importation, possession, sale, transfer and breeding of dangerous wild animals, SB406, makes various changes relating to wildlife, AB84, revises provisions relating to wildfires, AB202, revises provisions governing charitable lotteries and charitable games, and AB2, revises provisions governing the appointment by the Governor of members of boards, commissions and similar bodies.

Chairwoman East asked to make note the Senate Joint Resolution (SJR3), which urges Congress to provide funding to reduce wild horse and burro populations to appropriate management levels, also died out of Committee.

Management Analyst Kailey Taylor began with AB286, the bill passed out of the Assembly Committee. The Legislative Committee did not take a position on AB286.

Chairwoman East, Commissioner McNinch, Commissioner Hubbs and Commissioner Pierini had back and forth discussion around the provision in AB286.

Chairwoman East asked Game Warden Jake Kreamer on his thoughts about AB286.

Game Warden Jake Kreamer stated that Law Enforcement concerns were that there were no provisions in the bill to allow off-duty law enforcement to enter those premises in a concealed manner even with credentials.

Chairwoman East thanked him and asked for any more discussion. Seeing none, took it out for public comment. Seeing no public comment, brought it back to the Commission.

**NO POSITION TAKEN ON AB286 AS AGREED ON BY THE COMMISSIONERS.**

Management Analyst Kailey Taylor continued with SB78. The Commission had previously discussed the bill and taken a position to oppose as written, however, the bill had since been amended and the Commission would need to take a new position on the bill.

Commissioner Hubbs, Commissioner Caviglia, Commissioner AlMBERG, Vice Chair Barnes and Commissioner McNinch had discussion about SB78.

Chairwoman East went out for public comment. Seeing none, brought it back to the Commission for a motion.

**COMMISSIONER MCNINCH VOTED TO OPPOSE SB78 AS AMENDED. SECONDED BY COMMISSIONER PIERINI. MOTION CARRIES 9-0.**

Management Analyst Kailey wanted to update the Commission that AB89, which revises provisions relating to wildlife, Assemblywoman Titus' tag transfer, did pass the Assembly floor. She continued with AB299, the roadkill salvage bill. The Commission did vote to oppose this bill; however, an amendment was submitted.

Chairwoman East stated the impacts to the Department, the impact to Law Enforcement, it creates more work and other smaller impacts.

Commissioner Hubbs asked for clarification on some of the provisions.

Secretary Wasley clarified for Commissioner Hubbs that when the bill was originally introduced to create the authority to where anybody who desired to salvage an animal that had been killed on the road, had that opportunity. There are a number of comparisons to what other States have and do not have and are able to do; stated that he would caution those comparisons because every state is unique to itself. ] The Department's capacity and limitation were the biggest concerns.

Commissioner McNinch talked about his concerns to public health relating to the bill.

*Commissioner AlMBERG had connection issues, disconnected from the meeting.*

Chairwoman East thanked everyone for the discussion, asked for any additional discussion. Seeing none, went out for public comment. Seeing no public comment, brought it back to the Commission.

**NO ACTION TAKEN ON AB299 AS AGREED BY THE COMMISSIONERS. THE COMMISSION STANDS IN OPPOSITION POSITION.**

Management Analyst Kailey Taylor continued with AB211. The Committee voted to oppose as amended. The Department planned on submitting a fiscal note for one position.

Chairwoman East asked for discussion. Seeing none, went out for public comment. Seeing none, brought it back to the Commission for a motion.

**COMMISSIONER MCNINCH VOTED TO OPPOSE AB211 AS AMENDED ON THE PLATFORM THAT THE COMMISSION SUPPORTS THE ORIGINAL LANGUAGE THAT SUPPORTED A 30-DAY WINDOW AND FEE STRUCTURE. SECONDED BY COMMISSIONER HUBBS. MOTION CARRIES 8-0, COMMISSIONER ALMBERG ABSENT.**

*Commissioner AlMBERG reconnected and joined the meeting.*

Management Analyst Kailey Taylor continued with SB344, also known as the “Tiger King” bill. The Committee took no position. Stated that as written, it does not have anything to do with NDOW.

Chairwoman East asked for discussion. Seeing none, went out for public comment. Seeing no public comment, brought it back to the Commission for discussion or a motion.

**NO ACTION TAKEN ON SB344 AS AGREED BY THE COMMISSIONERS.**

Management Analyst Kailey Taylor continued with SB406. Explained the provisions of the bill and discussed the amendment.

Chairwoman East asked for Commission discussion. Seeing none, went out for public comment. Seeing no public comment, brought it back to the Commission for a motion.

**COMMISSIONER MCNINCH MADE A MOTION TO OPPOSE SB406 AS AMENDED WITH THE PLATFORM TO SUPPORT THE BILL AS ORIGINALLY PRESENTED. SECONDED BY COMMISSIONER HUBBS. MOTION CARRIES 9-0.**

Management Analyst Kailey Taylor continued with AB84. She stated that the Committee voted to support the bill.

Chairwoman East asked for discussion. Seeing none, went out for public comment. Seeing no public comment, brought it back for a motion.

**CHAIRWOMAN EAST MOVED TO SUPPORT AB84. SECONDED BY COMMISSIONER ALMBERG. MOTION CARRIES 9-0.**

Management Analyst Kailey Taylor continued with AB202.

Chairwoman East asked for discussion. Seeing none, took it out for public comment. Seeing no public comment, brought it back to the Commission for discussion.

**COMMISSIONER KIEL MOVED TO SUPPORT AB202. SECONDED BY COMMISSIONER ALMBERG. MOTION CARRIES 9-0.**

Management Analyst Kailey Taylor continued with AB2. The Committee has not taken position. The bill has passed Assembly floor.

Commissioner McNinch indicated that he believes it would be prudent to remain neutral.

Chairwoman East asked for any more discussion. Seeing none, went out for public comment. Seeing no public comment, brought it back to the Commission. She asked if it was the pleasure of the Commission to remain neutral and take no action.

#### **COMMISSION DECIDED TO REMAIN NEUTRAL AND TAKE NO ACTION ON AB2.**

#### **4. Future Commission Meetings – Secretary Tony Wasley – For Possible Action**

The next Commission meeting is scheduled for May 7 and 8, 2021. The Commission will review and discuss potential agenda items for that meeting. The Commission may change the time and meeting location at this time. The chairman may designate and adjust committee assignments as necessary at this meeting.

The next Legislative Committee Meeting is on April 30<sup>th</sup>. May 7<sup>th</sup> and 8<sup>th</sup> Commission meeting: big game quotas, presentation of the draft wildlife predation plan, Wildlife Heritage Committee meeting and report.
