1. Call to Order, Pledge of Allegiance, Roll Call of Commission and County Advisory Board Members to Manage Wildlife (CABMW) – Chairman Brad Johnston

Chairman Johnston called the meeting to order at 10:01 a.m. Roll call was conducted, and the Commissioners present were: Chairman Johnston, Madam Vice Chairwoman East, Commissioners Almberg, Barnes, Caviglia, Hubbs, Kiel, McNinch, and Valentine.

Chairman Johnston stated that he discussed this agenda item with Senior Deputy Attorney General Craig Burkett and that based on the circumstances for today's meeting, the Commission does not need to take public comment for this agenda item.

No comment or discussion from the Commission.

**CHAIRMAN JOHNSTON MOVED TO APPROVE THE AGENDA AS PRESENTED. COMMISSIONER MCNINCH SECONDED THE MOTION. THE MOTION CARRIED 9-0.**

3. Member Items/Announcements and Correspondence – Chairman Brad Johnston – Informational

Chairman Johnston stated he has received correspondence regarding the Heritage Auction Tags and that correspondence has also been shared with the Commission. He thanked members of the Department and Senior Deputy Attorney General Burkett for putting this meeting together. He stated that it may seem trivial to have a wildlife commission meeting with what is going on in the world, but he thinks it is vitally important that this Commission continue with its business. He thanked the Commissioners for being available for this meeting. He stated that thoughts and prayers are with those on the front lines of the pandemic and with those who have lost their jobs; he hopes everyone is safe given these unusual circumstances.

Madam Vice Chairwoman East provided comments about language in the minutes. She stated that on page 22, Jim Cooney of the Elko CABMW referenced a comment by Commissioner AlMBERG that is not in the minutes; and on page 38, she made a statement about the Nevada Sporting Dog Alliance, and the word “meat” needs to replace the word “need”.

Due to the complications with Chairman Johnston’s internet service and streaming capability, Madam Vice Chairwoman East recessed the meeting at 10:17 a.m. to allow for public comment via email.

Chairman Johnston reconvened the meeting at 10:35 a.m. and stated that no public comment was received for this agenda item.

**MADAM VICE CHAIRWOMAN EAST MOVED TO APPROVE THE MINUTES AS PRESENTED WITH THE EXCEPTION OF THE CHANGES SHE ASKED FOR ON PAGE 22 TO INCLUDE COMMISSIONER ALMBERG’S COMMENT, AND ON PAGE 38 TO CHANGE THE WORD “NEED” TO “MEAT” IN HER COMMENT. COMMISSIONER HUBBS SECONDED THE MOTION. MOTION CARRIED 9-0.**

6. Commission Regulations – For Possible Adoption / Public Comment Allowed
  - A.\* Commission Regulation 20-10, Migratory Game Bird Seasons, Bag Limits, and Special Regulations for Waterfowl and Webless Migratory Game Birds; Public Hunting Limited on Wildlife Management Areas and Designated State Lands – 2020–2021 Season – Wildlife Staff Specialist Russell Woolstenhulme – For Possible Action  
The Commission will consider recommendations for seasons, bag limits, and special regulations for migratory game birds for the 2020–2021 season and adopt regulations consistent with proposed regulations framework for the 2020–2021 hunting seasons on certain migratory game birds established by the U.S. Fish and Wildlife Service. The Commission Regulation will become final pending adoption of federal frameworks. The Commission will also consider rules regulating public hunting on Wildlife Management

Areas and designated state lands. \*Once the Commission members have discussed this agenda item, a recess of a specific duration will be taken in order for the public to provide input at the following email address: [wildlifecommission@ndow.org](mailto:wildlifecommission@ndow.org). Before reconvening the meeting, public comments will be shared with the Commission prior to taking any action.

Wildlife Staff Specialist Russell Woolstenhulme reviewed the support material provided in advance to the Commissioners, CABMW Chairmen and posted on the Department's website for the public.

Discussion ensued between Chairman Johnston and Wildlife Staff Specialist Russell Woolstenhulme regarding the scaup season and limits.

Commissioner McNinch inquired about the special youth waterfowl hunt open areas for the south zone regarding the Moapa Valley. Wildlife Staff Specialist Russell Woolstenhulme explained that the south zone includes the Moapa Valley; and that there is a special youth hunt on October 24 that is only held at the management area in Moapa Valley.

Commissioner Hubbs inquired about botulism issues in the waterfowl areas; she further inquired about how the habitat and wildlife are restoring after the botulism events and how is the species doing overall.

Wildlife Staff Specialist Russell Woolstenhulme stated that the waterfowl species was one of the two species that has not declined; and that eight of the best counts have happened in the last ten years; he provided statistics found in the support material regarding the continental waterfowl count. He provided further explanation and details about how the habitat has rebounded after the botulism outbreak and that good precipitation has put the habitat in a good place.

Commissioner Hubbs inquired what the Department has in place to manage future botulism events.

Wildlife Staff Specialist Russell Woolstenhulme provided that botulism occurs after large water events; that botulism is a western state problem that is ongoing; and that they are mitigating it the best they can.

Madam Vice Chairwoman East stated the Commission received a comment from the Elko CABMW to change the waterfowl season for the northeast zone which supports a start date of September 26 through October 20 and then October 30 through January 17, 2021; she inquired whether Wildlife Staff Specialist Russell Woolstenhulme had any issues with those requested changes.

Wildlife Staff Specialist Russell Woolstenhulme stated he has reviewed the dates and they are compliant with the federal framework; that he can make those adjustments to the Departments recommendations; and that he has no issues with them.

Chairman Johnston stated that Eureka CABMW commented in their Action Report about moving Eureka County into the northeast zone; he recalls that there are times it can be done or not be done and inquired where the Department is at in making this change.

Wildlife Staff Specialist Russell Woolstenhulme responded that he had this particular agenda item scheduled for the March Commission meeting; that this is one of those years that the zones can be set and this is likely why it was on the Eureka CABMW's radar. That agenda item was not placed on the April Commission Agenda and was not adequately noticed to be discussed today. He provided that the due date by the federal government was May 1, 2020 to make those changes. He has had discussions with the flyway, and they are understanding with the current health issue that the nation is facing right now, and they would be understanding if the Department brought this up at a later date for discussion.

Chairman Johnston inquired if the Commission could discuss the allowance of Eureka County into the northeast zone today; Wildlife Staff Specialist Russell Woolstenhulme responded that this would be a decision to be made by DAG Burkett.

Senior DAG Burkett stated he does not see why this would not be a part of the noticed agenda and that it could be addressed today.

Chairman Johnston stated that this topic has come up in the past in terms of setting dates and has been a consistent request by the Eureka CABMW and other stakeholders to have Eureka County a part of the northeast zone, and he would like to see it implemented now if possible. He further stated that the Commission had previously moved the start of the waterfowl season to the first Saturday of October. He has received public comment that the Carson CABMW's position was not accurately represented to the Commission. He has heard time and again that the waterfowl hunters in the northwest zone would like the start of their hunt pushed back one week to the second Saturday of October. He inquired if anyone else, including Mr. Woolstenhulme, has received public comment about this.

Wildlife Staff Specialist Russell Woolstenhulme stated that he coordinated with various groups this year on the waterfowl season in the northwest. He stated that he gets asked three things; one is to open the season earlier in October; secondly, others want the season to go as late as possible into the framework; and thirdly, others ask that the opener be the second Saturday which coincides with the upland game opening day. He provided further information as to how he came to determine the opening and closing dates; and that his goal is to keep hunter opportunity as the main priority.

Discussion ensued between Chairman Johnston and Wildlife Staff Specialist Russell Woolstenhulme about the opening date of the waterfowl season.

Commissioner Almberg stated that the Eureka CABMW has been vocal about their wishes to change the opening date in the northeast zone and he has no issue in making this change for them. He further stated that he has no issues with accommodating Elko CABMW's date change recommendations and hope the CABMW's in the northeast zone are listening today to speak up.

Commissioner Hubbs stated that based on her conservative nature she is more inclined to keep it as but would like to see what public comment is received today.

Wildlife Staff Specialist Russell Woolstenhulme stated that when the agenda item regarding the zones was on the March agenda, he had additional support material that he was going to discuss that the Commissioners do not have today. If the Commission makes changes to the zones, they will not take effect until the 2021-2022 season and would be in effect for five years. Any changes will not be for this particular season because it has to go through the federal process.

Discussion ensued that the Commission thought the changes made today would go into effect for this season and that the federal government would be willing to work with the Department; that this is the open period where the Commission can make changes for the 2021 – 2025 seasons, then the desired change goes through the federal process; and that the Department has been given some leeway for the May 1 deadline.

Commissioner Kiel inquired about which zones would be changing and if that included Lander and Eureka Counties moving to the northeast zone, and Esmerelda and Nye Counties moving to the south zone.

Wildlife Staff Specialist Russell Woolstenhulme stated that the support material that was originally included in the March Commission meeting agenda included his recommendation and rationale to those changes which is to move the zones in line with the Department's current regions. He provided further



explanation as to his recommendations. He stated that today the Commission is changing the dates to meet the needs of the specific hunters.

Commissioner Kiel stated he understands where Mr. Woolstenhulme is coming from and concurred that Eureka CABMW has been supportive of moving to the northeast zone. He inquired if Esmerelda or Nye CABMW has provided any opposition to the change of zones.

Wildlife Staff Specialist Russell Woolstenhulme stated that he reached out to specific counties to inquire for some input; he stated that he did not receive any opposition; and that Eureka and Lander CABMW's have been asking to move to a different zone. He reached out to Nye CABMW but did not hear back from them; he provided that Esmerelda CABMW did not have a lot of input because they do not have a lot of opportunity for waterfowl hunting, and they are looking more at upland seasons.

Deputy Director Robb stated that this topic was not put on the agenda because this would affect Nye County and due to the shutdown, they were not able to hold a CABMW meeting, so the Department did not receive any comments from them. He further stated that the Clark CABMW was another county that were not able to meet and provide comment.

Commissioner Almborg stated it seems with the lack of communication and lack of participation of the CABMW's based on the current world situation, he is inclined to agree with Commissioner Hubbs and will follow the Departments recommendations right now.

Deputy Director Jack Robb notified Chairman Johnston that he has heard from staff across the state that some of the rural areas are having a longer lag time than others on the YouTube channel. He requested a longer recess to allow for the slower lag time in rural areas.

Chairman Johnston recessed the meeting at 11:20 a.m. to allow for public comment via email at [wildlifecommission@ndow.org](mailto:wildlifecommission@ndow.org).

Mr. Chair and members of the Commission,

I would like to clarify that based on communications had through our Carson Recorder over the past 10 minutes, none of the Carson City CAB members have been contacted by Russell on the Northwest Zone seasons for Ducks and Mergansers and the Geese seasons. I just reached out to members of Canvasback Duck Club and they are primarily the ones requesting the early season start due to the fact that they can hunt their club sooner where all of the local ducks flock to when the hunting pressure at the public areas in Stillwater and Carson Sink. This is such a small demographic of sportsman and hunters and according to feedback we have received, are not the opinion and desire of the greater portion of the sportsman and waterfowl enthusiasts in our zone. My concern is that it is apparent that the greater portion of the waterfowlers that hunt the public areas have expressed that they would like the season started later and pushed back, and this proposed season does not reflect that. In fact, what I found interesting and didn't take into consideration is two of the waterfowl enthusiasts (non-hunters) that sent me email correspondence said they would much rather have the opportunity to take pictures and shoot video of waterfowl later in the season, when birds plumage is more brilliant, their thoughts are that hunters are push the different species of ducks that they desire to get photos and video of different species which isn't as prevalent if there is not much pressure pushing birds around.

Good morning, Commissioners,

I understand you're currently on a break and may not have voted on the proposed migratory game bird seasons so wanted to share my opinion on the matter. Please consider the following for public comment. I'm an extremely avid waterfowler throughout Nevada and I've seen a number of arguments for and against early and late season openers over the years. This year I think an opener of October 10<sup>th</sup> for the Northwest Zone would be a sound compromise between what NDOW would like to see and what the waterfowlers and wetland managers would like to see.

Regarding opening on the same date as upland seasons and especially chukar, I do not think this will impact the department of sportsmen negatively. In fact, I believe it will aid in reduced hunter congestion both in the marsh and on the mountain. I have hunted both types of birds in the same day in years past when they opened on the same day and my observation was that the guys that really wanted to be hunting a certain type of bird did so and the guys that wanted to do both also did so.

Commissioner Alberg inquired about Mineral CABMW because their comment was to move opening day forward to September 10 or September 17; now Mr. Bunch has stated that he is okay with moving it to a later date so Commissioner Alberg is unsure of what their wishes are at this time.

Discussion ensued that the zone changes will not be made today, but they can be discussed later and will need to go through the federal framework first to take effect in the 2021 season.

Commissioner Kiel moved to approve Commission Regulation 20-10 with some exceptions. Before the motion was finalized, there was more discussion.

Discussion ensued that if the Commission moves the start date in the northwest zone to October 10, 2020 as the regulation proposes, Mr. Woolstenhulme could make those changes to every season within those

zones; and that the motion could include the move to October 10 and all other dates will be modified to maximize hunter opportunity.

Commissioner Keil stated it was his intention to change all of the start dates to October 10 for the northwest zone and maximize the available hunting days under the federal framework; Madam Vice Chairwoman East agrees.

Commissioner Almberg states he agrees with the changes, but he does not feel comfortable because the Commission is missing comments from some of the CABMW's who cancelled their meetings and were not able to address this agenda item.

Commissioner Hubbs wants to follow a conservative approach and in light of the current situation with the participation numbers being down she would prefer to keep with the Department's recommendation.

Commissioner Barnes inquired with Commissioner Kiel about the motion and Elko CABMW's recommendation; discussion ensued regarding the Elko CABMW's northeast zone changes. Wildlife Staff Specialist Russell Woolstenhulme confirmed that the dates requested by the Elko CABMW of September 26 to October 20 and October 30 to January 17, 2021 are compliant with federal frameworks.

Chairman Johnston confirmed that Commissioner Kiel's motion was to adopt Elko CABMW's recommendation and that Madam Vice Chairwoman East is clear and is supportive of the motion.

Chairman Johnston inquired with Mr. Woolstenhulme that last year, duck season started on the third Saturday of October; Mr. Woolstenhulme concurred. Chairman Johnston stated that he sees Commissioner Almberg's concern about CABMW input but the Department's recommendation is a significant change from last year and what they are hearing from the public is to request an opening date of October 10 for the northwest zone to coincide with the upland season. The best compromise is to have an opening date in the northwest zone of October 10, 2020 and the ending should be that which maximizes hunter opportunity under the federal framework, which is consistent with the motion.

Discussion ensued between Commissioner Hubbs and Chairman Johnston that there is always an overlap between the waterfowl and upland game seasons; and that there is less congestion when the opening of the waterfowl season coincides with the opening of the upland game season because the upland birds are hunted in a different area than the waterfowl birds.

Commissioner Hubbs stated that she would be open to the compromise to move the opening date to October 10 as long as there is no risk and that it does not lead to excess congestion in certain areas; and that it does appear that the CABMW's want this change.

Recording Secretary Brandy Arroyo notified the Commission that two more comments had been received through email and inquired how to handle them since this was not an open comment period.

Senior DAG Burkett stated that the comment period is closed; Chairman Johnston concurred and that the public comment will not be received.

**ZONES IN ELKO CABMW'S RECOMMENDATION OF MOVING THAT LATER SEGMENT OF THE SEASON FROM OCTOBER 30, 2020 TO JANUARY 17, 2021; AND THE START DATES FOR THE NORTHWEST ZONE TO START OCTOBER 10, 2020. MADAM VICE CHAIRWOMAN EAST SECONDED THE MOTION. MOTION CARRIED 9-0.**

7. Wildlife Heritage Auction Tags – Deputy Director Jack Robb – for Possible Action  
Three of the Commission approved vendors for the 2020 Heritage Auction Tags canceled or may cancel their scheduled fundraising events due to COVID-19. The Commission may select an alternate method by which to auction these tags. Options may include, receiving sealed bids or working with the current vendor or other vendors that possess the ability to administer a live internet auction. The remaining unsold tags consist of One Antelope, One Desert Bighorn Sheep, One California Bighorn Sheep and One Rocky Mountain Elk. \*Once the Commission members have discussed this agenda item, a recess of a specific duration will be taken in order for the public to provide input at the following email address: [wildlifecommission@ndow.org](mailto:wildlifecommission@ndow.org). Before reconvening the meeting, public comments will be shared with the Commission prior to taking any action.

Chairman Johnston stated that he has received two letters regarding this agenda item; one is from Nevada Bighorns Unlimited (NBU) where they set out a proposal to use a platform called [onlinehuntingauctions.com](http://onlinehuntingauctions.com) to auction the Heritage Tags given to them as vendors; they noted that this would be part of a broader auction where they intend to auction off other items that they had intended to auction at their banquet. He stated that he did speak with Mr. Tom Fennell of NBU to obtain clarification of the auction specifics. He received a second letter from Wild Sheep Foundation (WSF) who will also use the same platform.

Deputy Director Jack Robb presented information in support of having an online auction for these tags which is supported by NRS 502.250(5), and that this is the only guidance the Commission is given in the statutes. There is no guidance to the Commission in the Nevada Administrative Code (NAC), but there is some guidance in Commission Policy No. 10 that allows the auction, resale, barter or trade with the approval of the Commission. He explained that due to the COVID-19 shutdown, various events have been cancelled which was the venue for tags to be auctioned at live events. He provided that there are other options to sell the tags; one would be to receive a sealed bid for the tags, but stated this is not a good option for those looking to make money because the buyer gets the item at a discount. Another option is to have the tags sold by the state approved auction vendor, TNT Auction; Mr. Robb provided how this option could work and how it could gain a lot of money, but there is a cost of 18 percent of sales to use their services. The Department was also contacted by the Wild Sheep Foundation (WSF) which offered to sell the tags through the same platform as NBU, and the WSF offered to do it at no cost to the Department.

Commissioner Hubbs inquired as to why there are just a few tags to auction off; Deputy Director Robb explained that some groups had completed their auctions prior to the closure of events due to the COVID-19 shut down, but other events have been cancelled. He requested that the group that is awarded the bid to sell or auction the tags be given the flexibility to auction the tags in a time frame that best represents the tags. He also provided that the tags need to be sold sooner than later because the people that are looking to buy big game tags will buy them at their first opportunity and the Department wants the Nevada tags sold before tags are sold in other states.

Discussion ensued regarding which platforms would allow the Department to earn the most money for these tags; that NBU and WSF have both offered to cover the fees for the Department to maximize the amount of money earned; and they both have agreed to accommodate the auction of all four tags.

Chairman Johnston provided his thoughts on the matter and stated he appreciates NBU and WSF for being proactive in coming to the Commission to offer their services in maximizing the value of these tags and he agrees that the online auction platform is the best route over a sealed bid. He further stated that the 18 percent off the top with TNT Auction is not a viable option. He likes that WSF and NBU have offered up a venue and are covering the costs so that 100 percent of proceeds go to the Heritage account; and that NBU is offering to do the auction with other items to gain the most funds. His personal view is to have NBU proceed with the auction of all four of the remaining Heritage Tags through [onlinehuntingauctions.com](http://onlinehuntingauctions.com).

Madam Vice Chairwoman East concurs with Chairman Johnston's thoughts and wants to know if NBU can be flexible on the dates. She inquired if the turkey tag could be sold as well; Deputy Director Robb responded that it is not a viable solution because the turkey hunts have already begun.

Commissioner Caviglia commented that WSF provided in their letter that all proceeds will go back to the Department and that NBU did not spell that out in their letter; he wanted to make sure there were no hidden costs if NBU was selected. Deputy Director Robb provided that he spoke to representatives of NBU and they have confirmed that all proceeds will come back to the state of Nevada even though it is not in their letter; Chairman Johnston concurred that is the same information he gained when speaking to Mr. Fennell.

Commissioner Almborg stated that he agrees with using NBU and if they needed help, they could reach out to WSF to market it.

Commissioner Hubbs inquired if the reach is the same if we go through NBU versus TNT Auctions. Deputy Director Robb stated that NBU has about 900,000 people who follow them and are willing to buy tags and that TNT Auctions has a different group of followers because they sell heavy equipment and surplus items.

Commissioner McNinch stated he agrees with voting for NBU. He inquired if the three-minute countdown could be included or just let them maximize things the way they see fit. Deputy Director Robb responded that there would need to be some flexibility to let NBU work with [onlinehuntingauctions.com](http://onlinehuntingauctions.com) on how to use the countdown and what date to use to get maximum exposure; he asked the Commission to allow for flexibility in the motion to regarding the countdown clock and the date of the auction.

Chairman Johnston stated that if this is what [onlinehuntingauctions.com](http://onlinehuntingauctions.com) does, then we should let them use their procedures and allow them to coordinate with NBU; they will maximize it and we do not need to dictate to them on how they do it.

Commissioner Barnes concurred with Chairman Johnston's comments; he stated that he works with an online cattle sale company and they have addressed these issues to not cut someone off that wants to bid higher; he agrees that the online auction is the best way to go and that the people who want these tags will find the auction to bid on them.

Commissioner Valentine stated that he is comfortable utilizing NBU with the four tags in the online auction.

Chairman Johnston thanked those who are participating in the meeting and providing public comment in an unorthodox way since we are currently living under unique circumstances.

8. Future Commission Meetings and Commission Committee Assignments – Secretary Tony Wasley and Chairman Brad Johnston – For Possible Action  
The next Commission meeting is scheduled for May 1 and 2, 2020, in Reno. The Commission will review and discuss potential agenda items for that meeting. The Commission may change the time and meeting location at this time. The chairman may designate and adjust committee assignments and add or dissolve committees, as necessary at this time. Any anticipated committee meetings that may occur prior to the next Commission meeting may be discussed. \*Once the Commission members have discussed this agenda item, a recess of a specific duration will be taken in order for the public to provide input at the following email address: [wildlifecommission@ndow.org](mailto:wildlifecommission@ndow.org). Before reconvening the meeting, public comments will be shared with the Commission prior to taking any action.

Chairman Johnston stated that the most pressing issue for the May Commission meeting is big game quota setting.

Secretary Wasley concurred. He thanked everyone for their flexibility for having their meeting in this format and thanked members of the Department for setting up the meeting by using Zoom, YouTube and a portal for public comment. It was all made possible by the Governor's Declaration and Directive to temporarily remove the requirement for a physical location for public input. That directive expires in the middle of April, but assuming it will be extended, the Department will be using this same venue for the next Commission meeting; however, should it not be extended, the Department will explore other options, such as meeting in person, for conducting the May Commission meeting. The big game quota process is done annually, and the Department tries to refrain from any large changes in off years unless there is a threat to the resource or there is an unutilized opportunity. Out of respect that this is an odd year and the challenge before the Department of getting public comment, there should be no large changes in the big game quota process. Secretary Wasley provided that the potential action items to be heard at the next meeting are as follows: approval of the Draft Predation Management Plan for 2021; big game quotas;

review and consideration of possible changes to Waterfowl Hunt Zones for the 2021 – 2025 and provided that this will be a different waterfowl process than what was heard today. There will be a potential workshop for Commission General Regulation (CGR) 490, Party Bonus Points and First Come First Serve; the goal is to have this in place this year to avoid the abuse of party bonus points. The potential adoption hearings would be for CGR 485, Tag Transfer, Deference and Return Program; CGR 490, Party Bonus Points and First Come First Serve; and CGR 491, Notification of Draw Results; however, it is not yet clear of the format of the next meeting and if the meeting will be held on two different days to have a potential adoption on the second day of the meeting; and it is not clear whether Kalkomey can accommodate any changes this year. The potential informational updates that have been requested by the Commission are as follows: an update on the Fallon Naval Range and Training Center and Nevada Test and Training Range and the Mandatory Indoctrination / Seminar for Bighorn Ram Tag Holders. The Department will defer to the guidance of the Chairman on the potential Committees and Reports that could be presented, and assuming that the committees are able to meet, and they are as follows: Status Report on the Application Hunt System is usually heard at the May meeting, but since the application period has been extended, this will need to be heard at a subsequent meeting; Big Game Status Report that usually accompanies quota recommendations; the Wildlife Heritage Committee Report; Wayne E. Kirch Wildlife Conservation Award Committee Report; Tag Allocation and Application Hunt Committee (TAAHC) Report; Wildlife Damage and Management Committee Report; Regulation Simplification Committee Report; Legislative Committee Report; Landowner Comp Tag Committee Report and Public Lands Committee Report. The Department needs to address the petition that was received from John Zenz regarding the big game tag drawing changes and confirm if he wants to make his presentation at a virtual meeting or if he prefers to do it in person.

Chairman Johnston stated that he has no additional items. He does expect that the same meeting format will be used as today; and if so, there will be a limited agenda. If at the next meeting the Department proceeds with CGR 490, Party Bonus Points and First Come First Serve, then he wants information on whether this will apply to current applications or only apply to future applications because people are already applying for party tags; he further wants to know when it would become available and how many people it would impact.

Commissioner McNinch stated the Coalition for Healthy Nevada Lands, Wildlife and Wild Horses has asked the Commission to look at Commission Policy No. 67, regarding feral horses and burros. He provided that he will talk to Secretary Wasley and Chairman Johnston of when the right opportunity would be to discuss this Commission policy.
