4. Approval of Minutes for September 3rd special meeting (**Approved via Email**).
5. **Commission Regulation 21-15, Fishing Seasons and Regulations for January 1, 2022, through December 31, 2023** – The Commission will establish fishing seasons, bag, and possession limits for the period of January 1, 2022, through December 31, 2023. **For Possible Action**

6. Commission General Regulation 488, Landowner Compensation Tags, LCB File No. R083-19 – The Commission will consider adopting changes to Chapter 502 of the Nevada Administrative Code (NAC). This regulation would provide direction for allocating landowner deer and antelope compensation tags if owner applicants cumulatively qualify for compensation tags in excess of the statutory limit. This regulation was considered during a workshop in September 2019. **For Possible Action**

7. Commission General Regulation 489, NAC 503.172, Shed Antler Season, R082-19 – The Board of Wildlife Commissioners will consider adopting changes to NAC 501 and NAC 503 to change the demerits for violation of the shed antler closure, increase the demerits for a violation of that regulation and require an online class in order to collect or possess shed antlers in the field. This regulation was brought as a petition by Elko CABMW in August 2019 and was considered during a workshop in September 2019 and August 2021. **For Possible Action**

8. Commission General Regulation 494 – NAC 501 Regulation Simplification, LCB File No. R163-20 – The Commission will consider adopting changes to NAC 501 recommended by the Regulation Simplification Committee. This regulation was considered during a workshop at the September 2020 meeting. **For Possible Action**

9. Commission General Regulation 499, Bonus Point Only Application Period – The Commission will review draft language amending NAC 502 chapters that would decouple the hunt application periods from

the 7-day bonus point only application period and create a separate period for bonus point only purchases that would facilitate a more timely draw process and provide increased opportunity for bonus point purchase. The change also defines what “awarded” means to a successful draw applicant. **For Possible Action**
