#### **1. Call to Order, Pledge of Allegiance, Roll Call of Committee Members**

The meeting was called to order at 8:04am. All committee members were present.

Committee Chairwoman East explained that she wanted the Committee to get together earlier in the legislative process to look at the bill draft requests (BDRs), determine spokesperson, and start discussions earlier.

Management Analyst Kailey Musso introduced Program Officer Alejandra Medina, who will be taking over legislative duties while Management Analyst Musso is on maternity leave. She explained that the legislative calendar is not out and will forward that to the Committee when it comes out. Lastly, the Committee was reminded that all BDRs are confidential until the bill language comes out.

Committee Chairwoman East also welcomed to Member Paul Young and Commissioner Mario Walther to the Committee this year.

**5. \*Review Department BDR Tracking List**

The policy list will be reviewed and prioritized for the Committee to begin the bill draft request (BDR) review process.

Management Analyst Kailey Musso presented the Department's BDR Tracking List. There are portions of the tracking list that likely will not be carried over to the Committee's tracking list. Once the Committee determines the BDRs they would like to keep an eye on, Department staff will transfer those onto a Committee tracking list. Important BDRs on the tracking list were made bold and were briefly discussed. Management Analyst Musso also went over the Joint Committee on Natural Resources BDRs as they were discussed during an open meeting to the public before submittal.

Committee Chairwoman East explained that she spoke with Assemblyman Watts regarding the predatory wildlife BDR submitted by the Joint Committee on Natural Resources. His intent with that BDR is to open it up so that the Department can use the predator fee towards other wildlife benefits. She also believes that BDR 128 may be related to wildlife contests.

She explained that her groups are working on a Myths and Reality paper which will likely be presented in late March.
