- 2* **Commission Regulation 20-12, Amendment # 1, 2021 -2022 Upland Game and Furbearer Seasons and Bag Limits.** The Board will review and make recommendation to the Commission as they establish and may vote to amend regulations for upland game birds and mammals as well as furbearers for the 2021-2022 season. This regulation may also include modifications to this fall wild turkey seasons for 2021 and spring wild turkey seasons for 2022.

- 3: **Commission Regulation 21-07 Amendment # 1, 2022 Heritage Tag Venders.** The Board will review and make recommendations to the Commission as they review Wildlife Heritage Committee's recommendations regarding Heritage Tag Vendor proposals for 2022 and may take action on the proposals.
