5. **Commission Regulation 21 – 01, 2021-2022 Raptor Capture Quotas** – The Commission will consider and may take action to approve the 2021-2022 season dates, species, quotas, limits, closed areas, application procedures and deadlines, and take of raptors for falconry. **For Possible Action** --- A motion was made by Ryan Collins and 2nd by Darell Mancebo to accept the Departments recommendations --- Motion Carries

- 6. Commission Regulation 21 – 02, 2021-2022 Noncommercial Collection Seasons and Bag Limits for Live, Unprotected Reptiles and Amphibians** – The Commission will consider and may take action to approve 2021-2022 season and limits for noncommercial hobby collecting of live, unprotected reptiles and amphibians. **For Possible Action** --- A motion was made by Darell Mancebo and 2nd by Ryan Collins to accept the Departments recommendations --- Motion Carries
- 7. Commission Regulation 20-04 Amendment #2, 2021 Heritage Tag Seasons and Quota** – The Commission will reexamine the 2021 Heritage Tag seasons as approved in January of 2020 and may consider adopting a regulation amendment to change one or more season dates. **For Possible Action** --- A motion was made by Ryan Collins and 2nd by Darell Mancebo to accept the Departments recommendations --- Motion Carries
- 8. Commission General Regulation 495, NAC 502 Simplification** – The Commission will review the Regulation Simplification Committee’s recommendations regarding language updates and simplification of Nevada Administrative Code (NAC) 502 relating to licensing. **For Possible Action** --- A motion was made by Ryan Collins and 2nd Darell Mancebo to not accept the Departments recommendations. The NAC 502.370 as suggested is just more requirements put on the hunter as well as the department staff. Most hunters are already doing this so why is another regulation needed. --- Motion carries

- 9. Commission General Regulation 496, NAC 503 Simplification** – The Commission will review the Regulation Simplification Committee’s recommendations regarding language updates and simplification of Nevada Administrative Code (NAC) 503 relating to wildlife. **For Possible Action** --- A motion was made by Ryan Collins and 2nd by Darell Mancebo to accept the Departments recommendations --- Motion Carries
- 10. Update on the Fallon Naval Range and Training Center and Nevada Test and Training Range** – The Department will provide an update regarding the legislative environmental impact statements status and timelines for Commission consideration of congressional correspondence relative to wildlife impacts. **For Possible Action** --- No Action
- 11. Petition – Cathy Smith – Prohibit the Use of Dogs on Bear Hunts** – Ms. Smith has submitted a petition to change NAC 503.147 to prohibit the use of dogs during a black bear hunt. This change is requested after a recent poll conducted by the Western Association of Fish and Wildlife Agencies (AFWA) in 2018. **For Possible Action** --- A motion was made by Ryan Collins and 2nd by Darell Mancebo to not support this petition --- Motion Carries
- 12. Petition – Chris Jasmine - Traditional Archery Mule Deer Hunt** – Mr. Jasmine has submitted a petition from the Traditional Archers of Nevada (TAN) requesting the Commission look at an increased opportunity for archery hunters willing to use more primitive equipment. The Traditional Archers of Nevada would like to establish a quota for traditional

archery for mule deer tags with no impact to other hunters, season dates, or quotas. The Commission may take action or deny or accept the petition and initiate rulemaking. **For Possible Action** --- A motion was made by Ryan Collins and 2nd by Darell Mancebo to not support this petition --- Motion Carries

13. Mule Deer Enhancement Teams – Each CAB is encouraged to compile a team to work with the Department of Wildlife and the area Biologist to plan a strategy for Mule deer success. **For Possible Action** --- We are working on getting our team together
