Board member Marquez toured and noted it is very dry, no flow. Board Chairman McVicars will reach out to the new supervisor and get some questions answered.

**10. A Commission General Regulation 490, Party Bonus Points and First Come First Serve, LCB File No. 103-19 – Data and Technology Services Division Administrator Kim Munoz and Management Analyst Kailey Taylor – For Possible Action**

Board discussed; Boren interpreted the NAC 502.4187 (2) to mean that in the event the hunter turns the tag in he loses his bonus points. Questioned if this was correct. Commissioner AlMBERG reviewed along with board members. AlMBERG confirmed that bonus points are lost unless everyone in the party returns their tag. All excuses were eliminated. Board confirmed that is what they wanted.

Public comment: Bill Miller; clarification on NAC 502.4215 (3) clarified that if you are not eligible then you are not allowed to apply during your waiting period. Commissioner AlMBERG, confirmed yes.

All board members are opposed to thermal imaging optics.

**12. Mule Deer Enhancement Program – Game Division Administrator Mike Scott – For Possible Action**

Board deferred to Menghini, NDOW for clarification. Action items will be developed to improve habitat, using advice from local experts. Envisions group gets together regularly to develop a plan to turn mule deer quantities /quality around. Boren praised the departments success with big horn and is enthusiastic regarding the attention they are now showing Mule Deer. Menghini, NDOW is hopeful for both short- and long-term goals. Much of the work the department is doing goes un-discussed, looking forward to sharing their discoveries as well as hearing from the public. Boren would like to see collaring. McVicars sees opportunity for ranchers to assist with water options. Board concurs this will open a lot of positive opportunity

Public comment: Commissioner Almborg, noted how lucky we are in this area. Sees a potential issue with managing all of the great ideas that will come from this program. Boren questioned the process. Will the ideas ever come back to the CAB's for input? Menghini foresees that happening.

*A motion to accepted Mule Deer Enhancement Program concept by board member Boren, seconded by board member Masetes. Motion passed, no opposition.*

*Menghini reviewed.
