

NEVADA LAW DOES NOT REQUIRE HARVEST OF EDIBLE PORTIONS

NRS 503.050

Wanton Waste Statute

NRS 503.050 Unlawful to waste game bird, mammal, fish or amphibian.

- 1. It is unlawful for any person to cause through carelessness, neglect or otherwise any **edible portion** of any game bird, **game mammal**, game fish or game amphibian to go to waste needlessly.
- 2. It is unlawful for any person to capture or destroy any game mammal, **except a carnivore**, and detach or remove from the carcass the head, hide, antlers, horns or tusks only and leave the carcass to waste.
- 3. For the purposes of subsection 1, "game bird" does not include a raven, crow or magpie even if classified as a game bird pursuant to <u>NRS 501.110</u>.

NRS 503.050

- NRS does not require harvest of edible portions due to carnivore exception added in 1969
- Bears and mountain lions taxonomically defined as being in the order carnivora
- NV black bear hunting established 2011

NAC 503.0047

- Defines how "edible portion" applies to both big game mammals and game mammals
- Dual classification of both black bears and mountain lions creates confusion in interpreting regulation only wolves, peccaries, and rabbits are not classified as both big game and game mammals
- Exception for mountain lions and black bears in subsection 1(a)

NAC 503.0047

NAC 503.0047 "Edible portion" interpreted.

501.105, 501.181, 503.050)

1. As used in NRS 503.050, the Commission will interpret "edible portion" to mean, with respect to:

(a) A big game mammal, except mountain lions and black

bears:

(1) The meat of the front quarters to the knee;
(2) The meat of the hind quarters to the hock; and
(3) The meat along the backbone between the front quarters and hind quarters;

(b) A game mammal:

(1) The meat of the front quarters to the elbow;
(2) The meat of the hind quarters to the hock; and
(3) The meat along the backbone between the front quarters and hind quarters;

(c) A game bird, the meat of the breast; and (d) A game fish, the fillet meat from the gill plate to the tail

Dual Classification

- NAC 502.020 "Big game mammal" defined. (NRS 501.105, 501.181) "Big game mammal" means any:
- 1. Pronghorn antelope, black bear, mule deer, mountain goat, mountain lion, moose, Rocky Mountain elk; or
- 2. Of the following subspecies of bighorn sheep:
- (a) Nelson bighorn sheep;
- (b) California bighorn sheep; or
- (c) Rocky Mountain bighorn sheep.

Proposal

• Amend NRS 503.050 to remove "carnivore" exception, replace with "gray wolves"

• Amend NAC 503.0047(1)(a) to strike "except mountain lions and black bears"

NRS 503.050 Unlawful to waste game bird, mammal, fish or amphibian.

- It is unlawful for any person to cause through carelessness, neglect or otherwise any edible
 portion of any game bird, game mammal, game fish or game amphibian to go to waste needlessly.
- It is unlawful for any person to capture or destroy any game mammal, except a carnivore gray wolf, and detach or remove from the carcass the head, hide, antlers, horns or tusks only and leave the carcass to waste.
- For the purposes of subsection 1, "game bird" does not include a raven, crow or magpie even if classified as a game bird pursuant to NRS 501.110.

NAC 503.0047 "Edible portion" interpreted. (NRS 501.105, 501.181, 503.050)

- As used in <u>NRS 503.050</u>, the Commission will interpret "edible portion" to mean, with respect to:
- (a) A big game mammal, except mountain lions and black bears:
 - The meat of the front quarters to the knee;
 - (2) The meat of the hind quarters to the hock; and
 - (3) The meat along the backbone between the front quarters and hind quarters;
- (b) A game mammal:
 - (1) The meat of the front quarters to the elbow;
 - (2) The meat of the hind quarters to the hock; and
 - (3) The meat along the backbone between the front quarters and hind quarters;
- (c) A game bird, the meat of the breast; and
- (d) A game fish, the fillet meat from the gill plate to the tail fin.
- The term does not include:
- (a) Meat from the head or neck;
- (b) Meat that has been damaged and rendered inedible by the method of taking;
- (c) Meat that is reasonably lost as a result of boning or close trimming of bones;
- (d) Bones;
- (e) Sinew; or
- (f) Viscera.
- As used in this section:
- (a) "Elbow" means the distal joint of the humerus.
- (b) "Gill plate" means the operculum.
- (c) "Hock" means the distal joint of the tibia-fibula.
- (d) "Knee" means the distal joint of the radius-ulna.
- (e) "Tail fin" means the caudal fin.
